Food vendors for the South Lake Tahoe Earth Day event are required to obtain a Temporary Food Establishment Special Event permit through El Dorado County Environmental Management, 3368 Lake Tahoe Blvd. #303/302, South Lake Tahoe, CA 96150, 530.573.3450. Additional information can be found at: www.edcgov.us/emd/envhealth/food_program.html. Vendors selling products must have a Business and Professions Tax Certificate from the South Lake Tahoe City Finance Department, a temporary seller's permit from the State Board of Equalization and a Application for Temporary Food Facility Permit for Community Events.

*Making the South Lake Tahoe Earth Day a zero waste event is an important element of our event. To make this a reality, all food item materials, i.e., plates, napkins, cups, spoons and forks, are required to be compostable. Paper plates and cups that are non-waxed are acceptable. To offset costs for the event, food vendors are required to donate 10% of their profits on the day of the event. Please pay at the end of the day with cash or check made out to **Tahoe Earth Day Foundation**. Food vendors will be limited to a number appropriate to the size of the event and the variety of food offered, with priority given to local vendors who have participated in past events.*
